
Gary and I feel grandchildren are the best thing invented since chocolate.



I'm looking forward to retiring. I work three days a week now. Life is good!!



Diana lives in Isanti and is getting married September 28th to Adam Dordal. They have a 7 year old son Cole.


I still play the piano, love to travel, especially to my parents in Texas (where it's free to stay!) and enjoy my grandchildren.



Art Instruction School: I entered several contests during my high school years, and I received several merit awards, and in addition I received several cash prizes from them.
